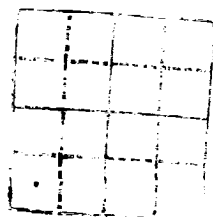

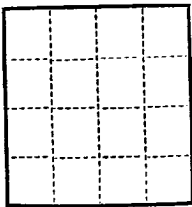

It is intended to drill a well with rotary tools through the Mesa Verde drilling the pay section with gas circulation, and to sand-oil the Cliff House and Point Lookout formations. Total Depth 6050'.

7" at 5480' with 250 sacks Formix and 250 sacks regular cement.

The 1/2 of Section 31 is dedicated to this well.
