It is intended to drill with rotary tools and mud circulation thru the Pictured Cliffs formation, to set intermediate casing, drill with gas circulation thru the Mesa Verde formation, set liner, perforate and sand frac possible productive intervals in the Mesa Verde formation.

7", 20.0¢ at 3615' with 250 sacks cement.
5 1/2", 15.50¢ at 5955' with 150 sacks cement.
