DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

The well was spudded at 2:10 A.M., October 14, 1953. On October 15, 1953, 9-5/8" casing was landed at 275 feet and cemented with 180 sacks of cement. Cement plug down at 5:52 A.M., October 15, 1953. At 7:30 P.M., October 16, 1953, casing and water shut-off was tested at 500 pounds for 30 minutes, with no drop in pressure. Forty-five feet of solid cement were drilled in bottom of pipe and water shut-off was again tested at 500 pounds for 30 minutes. There was no drop in pressure during this test and drilling operations were resumed.
