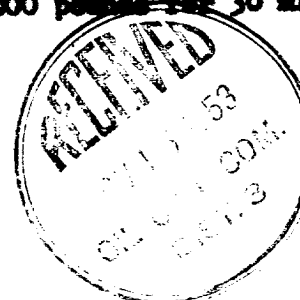

DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

On October 26, 1953, 7" casing was landed at 4412 feet and cemented with 420 sacks of cement. Plug down at 3:11 P.M., October 26, 1953. At 3:00 P.M., October 26, 1953, casing and water shut-off were tested at 1000 pounds pump pressure for 30 minutes. No drop in pressure. Forty-six feet of solid cement were drilled in bottom of pipe and water shut-off was again tested at 1000 pounds for 30 minutes. No drop in pressure. Drilling operations were resumed.
