DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Well was drilled to a total depth of 5243 feet with rotary tools. Shot formation from 4620 to 5243 feet open with 1436 quarts Hercules slow detonating explosive. Well was cleaned out to total depth with gas and 2" tubing landed at 217 feet. Well shut in 7 days. Shut in casing pressure 1062 psi. Three hour potential test 4302 MCFFD, September 15, 1953.

Well shut in for pipe line connection.
