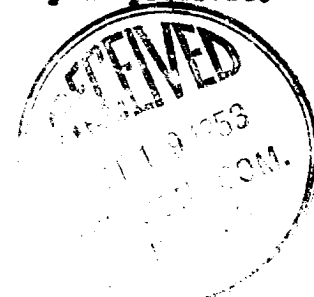

DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

On August 30, 1953, 7" casing was landed at 4551 feet and cemented with 420 sacks of cement. Plug down at 9:01 P.M., August 30, 1953. At 9:00 P.M., September 1, 1953, casing and water shut-off were tested at 1250 pounds pump pressure for 30 minutes. No drop in pressure. Forty-nine feet of solid cement were drilled in bottom of pipe and water shut-off was again tested at 1250 pounds for 30 minutes. No drop in pressure. Drilling operations were resumed.
