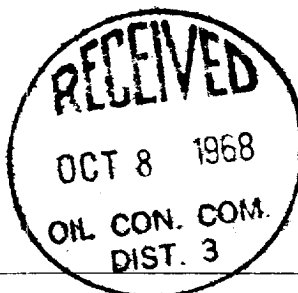

9-24-68 TO 4394' RKB. Cleaned out to 4368' RKB. Perforated 4292-4302' with 20 shots and 4240-4260' with 20 shots. Ran tubing with packer set at 4275'. Acidized bottom perforations with 12 barrels acid. Established communication with upper zone perforations after displacing approximately 11½ barrels acid into lower zone.

9-26-68 Fraced with 200,000# 20/40 sand plus estimated 26,000# 10/20 sand, mixed with 3,400 barrels crude oil. Average overall injection rate 86 BPM. No apparent breakdown pressure. Min. TP 2900#, max. 4500#, avg. 3100#. Well sanded off at 4800#.

9-30-68 Started flowing back load oil.

Instructions
