13. Describe Proposed or Completed Operation (clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. After further evaluation, plans are now to just TA the subject well by setting a CIBP above the top perf and then pressure testing the casing. If the casing passes the pressure test, we will keep the wellbore available for future coalseam completion. If the casing fails to test, we will call with plans to P&A the subject well. Plans are still to do this work in the spring of 2001 after the winter closure period.
