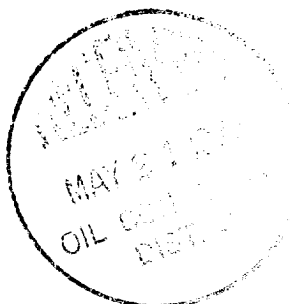

5-14-77 Ran 86 jts of 7", 20#, K-55, 8rd casing. Total 3412.32', shoe set at 3400', insert float valve at 3360.30'. Cemented with 150 sacks 65/35 Poz, Class B with 12% gel, 12.5# fine gilsonite per sack followed by 70 sacks Class B with 2% CaCl and 12.5# gilsonite per sack. Plug down at 6:40 P.M.

5-18-77 Ran 61 jts of 4-1/2", 10.50#, K-55, 8rd casing. Total 2494.01', shoe set at 5741', float collar at 5740', liner hanger at 3235.39'. Cemented with 315 sacks 65/35 Poz A, Class B with 2% gel, 6.25# fine gilsonite per sack, 1/4# gel flake per sack and 0.6% D-19. Plug down at 10:35 AM.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.

Item 17: Proposals to abandon a well and subsequent reports of abandonment should include such special information as is required by local Federal and/or State offices.
