8-13-77 Spud 12 1/4" hole. Set 8 5/8" casing at 139' KB. Cemented with 85 sacks Class "B" with 1/4# flocele per sack. Circulated 4 Bbls. Tested casing to 600 psi for 30 minutes. Held OK. Drilled 6 3/4" hole to 1951' with mud.

8-18-77 Ran I-ES and GR Density logs. Ran 2 7/8" casing set at 3620' KB. Cemented with 130 sacks Class "B" 65/35 poz with 12% gel and 12 1/2# fine gilsonite per sack followed by 50 sacks Class "B".
