Completion work began on 1/4/78. Tripped in with tubing and drilled cement to BBD of 5322'. Pressure tested casing to 3000 psi for 15 minutes; held OK. Perforated 4333-45, 4434-39, 4449-53, 4476-79, 4544-47, 4566-69, 4626-4703, 4739-42, 4748-53, 4762-66, 4768-70, 4822-36, 4867-70, 4927-44, 5006-15, 5086-94, 5103-08, 5114-17, 5122-51, 5156-65, 5177-79, 5194-5200. Sand-water fraced in three stages using 262,160# sand and 144,188 gallons frac fluid consisting of 1% KCL and 1 gallon surfactant and 20# gel per 1000 gallons water.

Production tubing landed at 5173'.
