Completion operations began 1/13/78. Ran 2-3/8" tubing; cleaned out to 5105' PBD. Pressure tested casing to 3000 psi; held OK. Perforated 4154-4499, 4562-4798, 4874-5086. Foam fraced in three stages with 270,400 lbs. sand and 142,720 gallons frac fluid. Tripped in with tubing and cleaned out sand and water to PBD of 5105'. Production tubing set at 5975'. Opened well to atmosphere. Three hours to clean up.
