Several attempts have been made to schedule this well to have the fill removed, but because of weather and problems scheduling the four service companies needed to complete this work it hasn't been completed.

This is a slimhole completion and there is only one coiled tubing unit in the area that can run this the coiled tubing to clean out this fill. This truck weighs approximately 130,000#, and is very top heavy and requires good road conditions to maneuver around in the field. The truck got stuck in February while going to this well and it took a large CAT to pull it from the mud. Since then it has been schedule and rescheduled over a half dozen times either because of the weather or coordinating Baker, BJ Services and Blue Jet all on the same day.

Phillips wishes to extend the time period for getting this well back on line a little longer. They had everything scheduled for this morning, but because of the snow, Phillips couldn't take the liability of moving the coiled tubing truck in again. We are working to reschedule this clean out for this weekend and hopefully it will be done. We are asking for a little more time.
