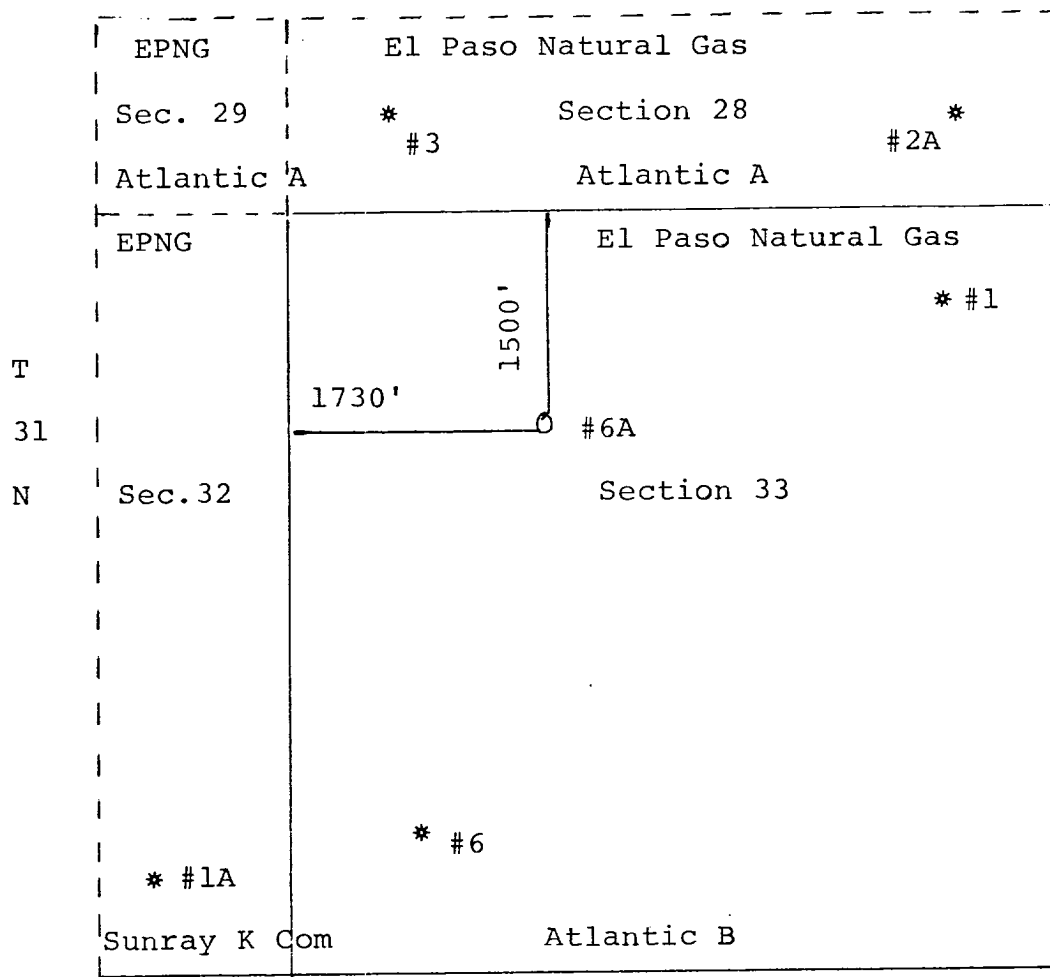

If, after said twenty-day period, no protest nor request for hearing is received by the Santa Fe office, the application will then be processed.
