2. Check and record tubing, casing, and bradenhead pressures.
3. Blow down wellhead. Kill with water if necessary.
4. Nipple down WH. NU BOPs.
5. TOH and LD 1-1/4" production tubing.
6. PU 2-3/8" workstring.
7. TIH w/4-1/2" CIBP & set @ 2950'. PU and spot 450' cement plug (40 cu ft) above CIBP from 2500'-2950' to cover Picture Cliffs and Fruitland intervals.

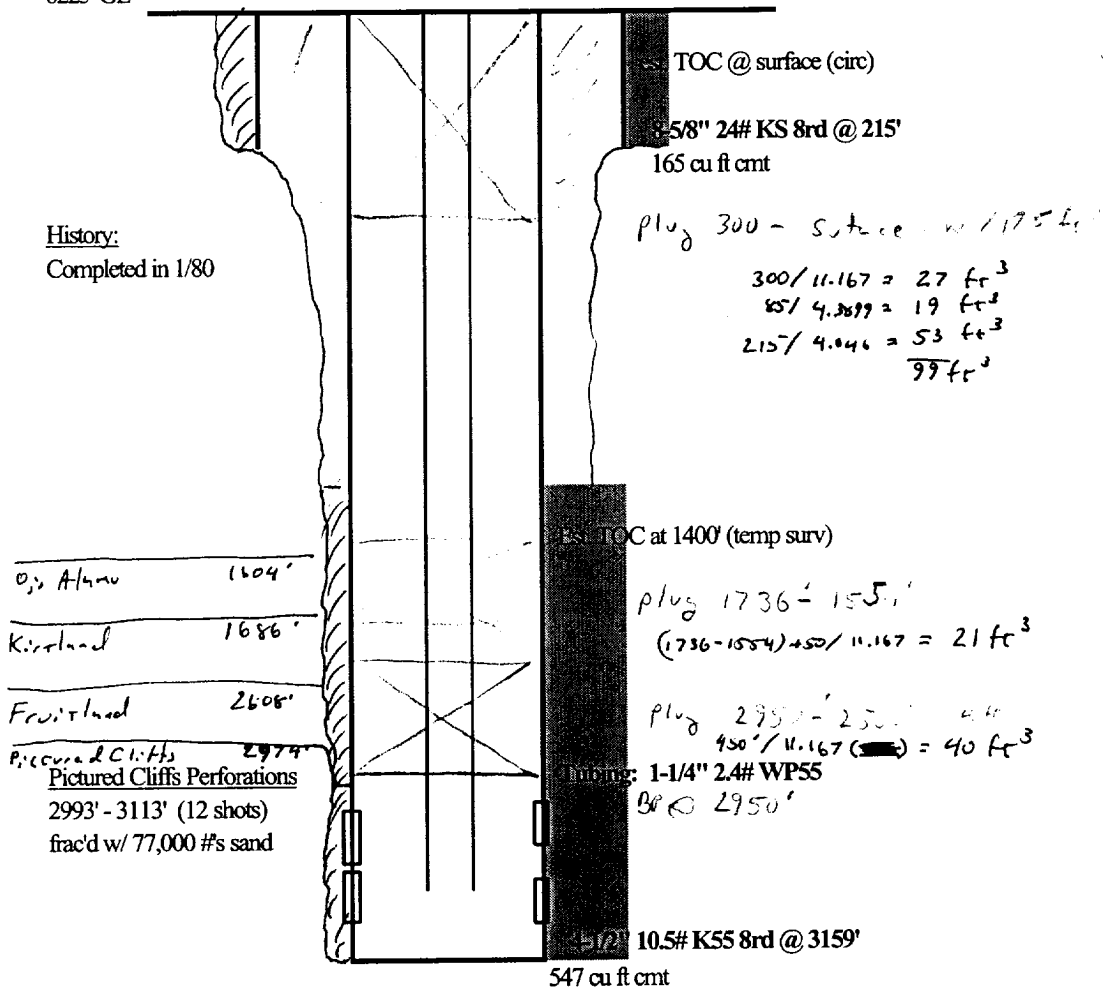
