Stung out of cement retainer and tripped out of hole with tubing. Circulated wellbore clean. Found casing leak from 2828' to 4022'. Spotted 75 sacks (88.5 cu ft) class B neat w/2% calcium chloride across leak. Pressure displaced 33.7 cu ft into formation. WOC 4 hrs. Tagged top of cement @ 3079'. Pressure tested to 750 psig. Held ok. Drilled out cement to 3614'. Pressure tested to 750 psig. Did not hold. Leak was from 3300' to 3614'. Spotted 50 sacks (59 cu ft) class B neat w/2% calcium chloride across leak. Pressure displaced 25.3 cu ft into formation. WOC 12 hrs. Tagged cement @ 3121'. Drilled cement out. Pressure tested casing to 600 psig. Held ok. Tripped tubing back into well bore and stung into cement retainer.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
