Spudded 13 3/4" hole on 5/21/79 and drilled to 235'. Ran 5 jts 9 5/8", 36#, K-55 csg and set @ 235'. Cemented w/160 Sx class "B" cement w/2% CACL2. Circulated 16 bbls to surface. WOC 12 hrs. NUBOE. Pressure tested to 1000 psi for 30 min-held ok. Reduced hole to 8 3/4" and drilled to 3500'. Ran 81 jts 7", 23#, K-55 csg & set @ 3500'. Cemented w/540 Sx 50/50 poz mix, 4% Gel, 6 1/2# Sx Gilsonite, 1/4# Sx Celloflake, followed by 100 Sx class "H" cement w/2% CACL2. WOC 12 hrs. NUBOE. Reduced hole to 6 1/4" and continued drilling.
