Spudded 13 3/4" hole on 7/10/79 and drilled to 220'. Ran 5 jts 9 5/8", 36#, K-55 csg & set @ 217'. Cemented w/175 Sx class "B" cement, 1/4# Sx Flocele, 2% CACL2. Circulated to surface. WOC 12 hrs. Reduced hole to 8 3/4" and drilled to 3250'. Ran 7", 23#, K-55 csg & set @ 3252'. Cemented w/475 Sx Howco Lite followed by 150 Sx class "B" cement w/2% CACL2. WOC 12 hrs. Reduced hole to 6 1/4" and drilled to T.D. @ 7140' on 7/20/79. Ran electric logs. Ran 119 jts 4 1/2", 10.5# & 11.6#, K-55 csg w/liner & set @ 7133' w/top of liner @ 3112'. Cemented w/443 Sx Howco Lite, 6 1/4# Sx Gilsonite, 1/4# Sx Flocele, 0.1% Halad-9, followed by 100 Sx class "B" cement & 20 bbl mud flush. WOC 12 hrs. Released rig. WOCU.
