Reference is made to your application of February 27, 1989 for a non-standard coal gas well location for your Johnston Federal Well No. 16 located 820 feet from the North line and 1040 feet from the West line (~~Unit D~~ of Section 33, Township 31 North, Range 9 West, NMPM, Basin Fruitland Coal (Gas) Pool, San Juan County, New Mexico. The W/2 of said Section 33 shall be dedicated to the well forming a standard 320-acre gas spacing and proration unit.
