We propose to open and stimulate all the Fruitland Coal intervals in the subject gas well. We anticipate a gas increase of 300 MCF/D with a reserve increase of 1130 MMCF. This well was completed on 2/19/81 as a Pictured cliffs gas well but was never delivered to pipeline due to excessive water production. A direct offset well, the Johnston Fed #23 (SE 35-31-9), has averaged 766 MCF/D and 112 BWPD since its first delivery on 12/27/89. The Johnston Federal #23 was opened and stimulated in all Fruitland Coal intervals.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
