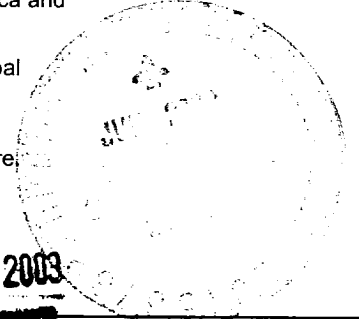

Please reference telephone conversation on May 17, 2002, between representatives of BP America and Steve Mason, BLM and Charlie Perrin, NMOCD, regarding bringing various inactive wells into compliance.
The subject well was approved for continued shut-in status on 02/13/2002 until 08/15/2002. Verbal permission was granted to temporarily abandon the well (i.e. pressure test for casing integrity) in order to bring well into compliance and hold for possible production stimulation in the current zone or recompletion into the Fruitland Coal Formation. If the casing integrity test fails we will proceed immediately with plug and abandonment operations as per previously approved procedure. After final review, if no future potential exists in the wellbore we will file for approval and proceed to plug and abandon in accordance with approved plug and abandonment procedures.

We have performed a successful CSG integrity for the subject well as follows:
