Activities for Previous Two Quarters (Oct. - Dec. 1996 & Jan. - Mar. 1997):

On December 11, 1996 and again on March 3, 1997, PNM performed water level measurements and quarterly sampling of groundwater in all monitoring wells at the Templeton 1E. Samples were collected in each well for chemical analysis of benzene, toluene, ethylbenzene, and xylenes (BTEX) using EPA method 8020. In all instances, PNM adhered to EPA protocol when collecting and transporting the samples. Groundwater samples were delivered to OnSite Technologies, Farmington, New Mexico.

Results:

Figure 1 provides a map showing BTEX analytical data for each monitoring well since groundwater contamination was discovered at the site. For the previous four consecutive quarters, BTEX concentrations have been non-detectable or below Water Quality Control Commission (WQCC) standards.

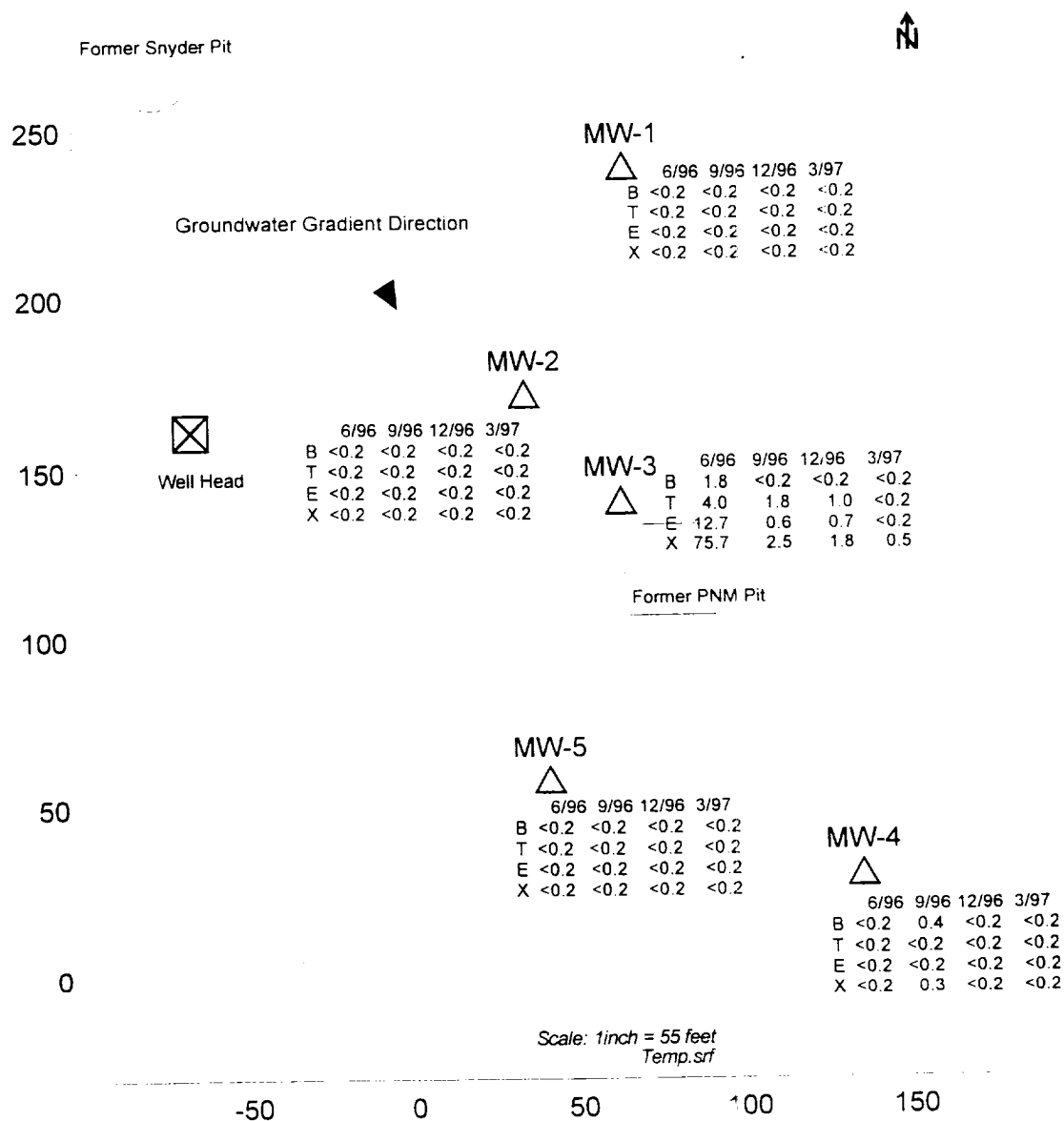


Figure 2. Templeton 1E Groundwater Contour Map (December 1996)

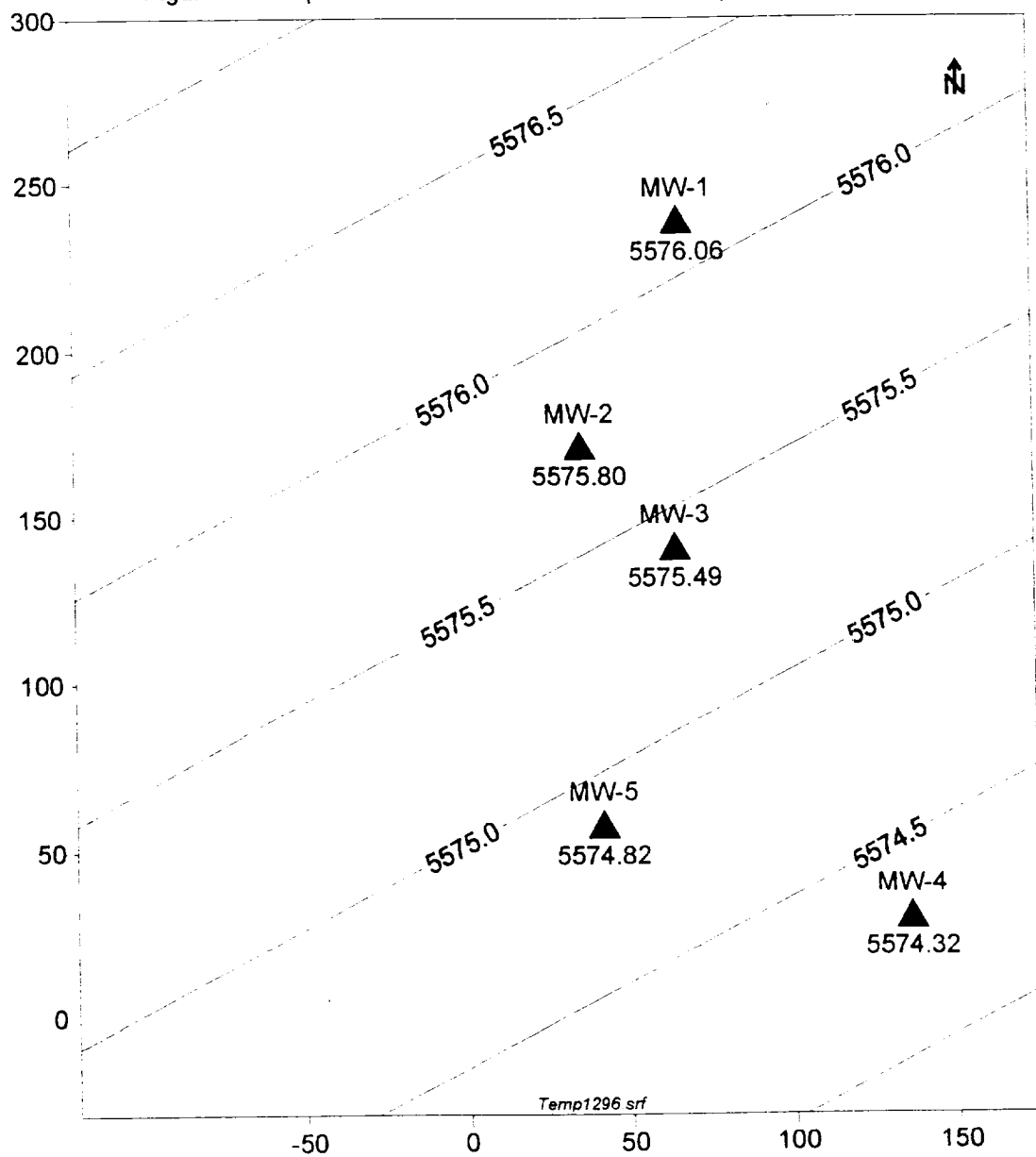


Figure 3. Templeton 1E Groundwater Contour Map (March 1997)

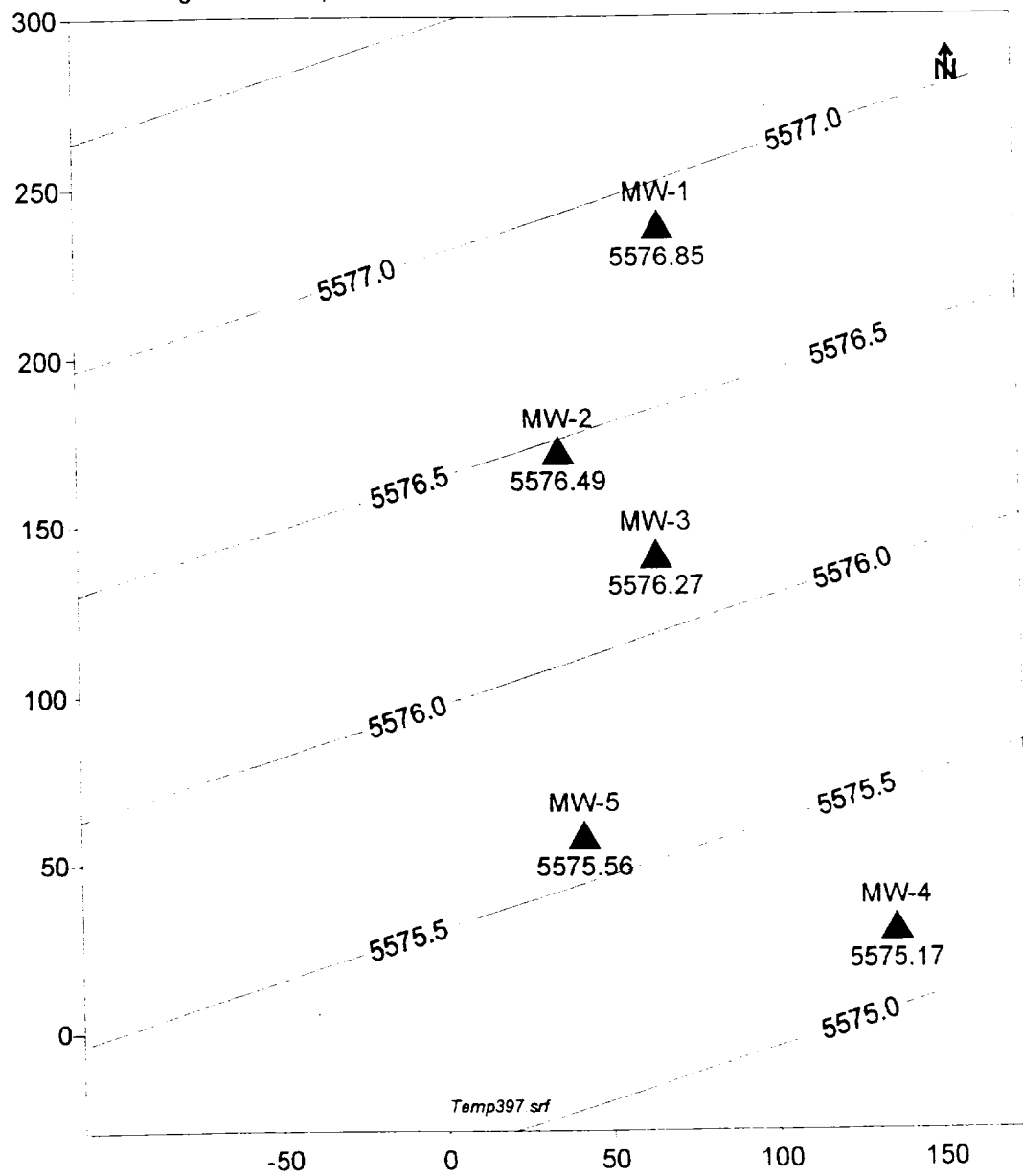
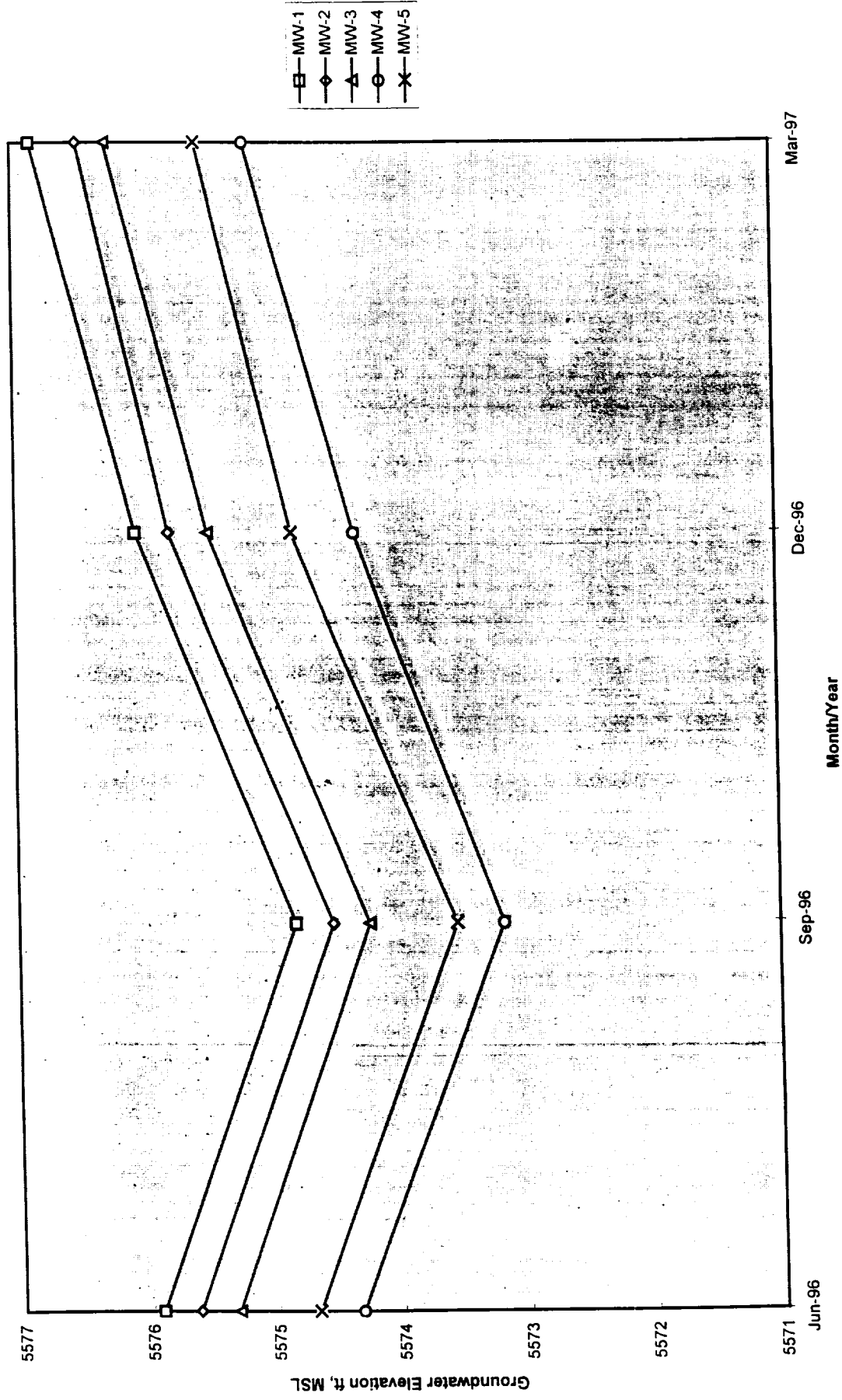


Figure 4. Templeton 1E Hydrograph

Figures 2 and 3 provide groundwater contour maps of the site for the fourth quarter 1996 and the first quarter 1997, respectively. The groundwater flows in a southeastern direction beneath the site. Figure 4 presents a groundwater hydrograph of the site since monitoring began. Water levels have risen over the last two quarters due to increased precipitation in the region.

Further Action:

Consistent with PNM's San Juan Basin Groundwater Management Plan, we request closure of the Templeton 1E. This request is based upon the analytical data collected over the last year at the site. BTEX concentrations have been consistently below WQCC standards for four consecutive quarters.

Upon completion of monitoring and remedial actions, PNM will plug and abandon the five groundwater monitoring wells at the Templeton 1E. The concrete pad and the metal vault surrounding each well will be removed. The well casing will be cut to ground surface and each well will be plugged to the surface with cement containing 5% betonite.

(Concentrations in ppb)
