DRILLING, CASING AND CEMENTING PROGRAM.

- 1. MIRURT
- 2. Drill a 12½" Hole to \pm 250 with Sel-Mater Mud.
- RU and run 9 5/8" 36# K-55 ST&C casing to TD. Cement with Class B + 2% CaCl₂ in sufficient quantity to circulate cement to surface. WOC 12 hours.
- 4. Screw on 9 5/8 8rd x 11-3000 casing head, NU BOPS. Pressure test casing, lines and blinds to 1000 PSI for 30 minutes. GIH with drill pipe and test pipe rams to 1000 PSI for 30 minutes. Record all tests on IADC Report.



- 1. Existing Road Please refer to Map No. 1 which shows the existing roads. New roads which will be required have been marked on this map. All existing and new roads will be properly maintained during the duration of this project.
- 2. Planned Access Roads Please refer to Map No. 1. The grade of the access roads will be consistent with that of the local terrain. The road surface will not exceed twenty feet (20') in width. Upon completion of the project, the access road will be adequately drained to control soil erosion.
