7-24-82 Drilled 8-3/4" hole to a total depth of 3724'. Ran 90 joints (3712') of 7", 20# K55 casing set at 3724'. Cemented first stage with 230 sacks of Class "B", 50/50 POZ, 6% gel. Tail in with 100 sacks of Class "B", 2% CaCL2. Plug down at 5:00 pm, 7-24-82. Top of cement at 1700' by temperature survey.

7-26-82 Drilled 6-1/4" hole to 5984' and logged.

7-27-82 Ran 58 joints (2381.65') of 4-1/2", 10.5#, K55 casing set from 3567' to 5949'. Cemented with 330 sacks of Class "B", 50/50 POZ, 1/4# celloflake, .6% FLA, 6% gel. Plug down at 6:40 am on 7-27-82.
