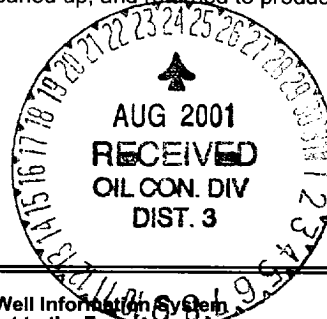

It is intended to retrieve the 5-1/2" liner, re-enter the open-hole interval, clean and drill out 220' of new hole to 3609' with a 6-1/4" bit, 2-7/8" drill pipe, and air-mist. The open-hole interval will be logged and a 5-1/2" pre-perforated liner will be run. The Fruitland Coal will be stimulated via conventional fracturing methods, cleaned up, and returned to production.
