This well was cleaned out and returned to sales September, 1997. However, the well pressure cannot produce against the high line pressure prevailant in this area.

On September 29, 1999 well was turned on, and well flowed 126 MCF, 0 BW, FCP 400# on 2" choke. SG plans to restart the pumping unit and try to return well to production.
