Pressure tested casing to 800 psi. Drilled a 7 7/8" hole to a TD of 3455' on 11-3-90. Set 5 1/2" 17# K55 LTFC production casing at 3262'. Cemented with 1st stage 122 sx class G Donnell 65/35po2, tail w/ 200 sx class G Donnell (2nd stage) 408 sx class G Donnell 65/35po2, tail with 60 sx class G Donnell. Circulated \* BBLs good cement to the surface.

\* DV tool set @ 1883' no cement circulated to surface 1st stage.  
2nd stage circulated 37 BBLs to surface.

## GENERAL INSTRUCTIONS

Any necessary special in-

structions concerning the use of this form and the number of copies to be submitted, particularly with regard to local area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

## SPECIFIC INSTRUCTIONS
