Pressure tested casing to 1000 psi. Drilled a 7 7/8" hole to a TD of 2932' on 12-1-90. Set 5 1/2" 11# K-55 LTC production casing at 2926'. Cemented with 1st stage 110# X CG Donnell 65/65 tail w/ 200# B G Donnell 65/65 (2nd stage) 305# X CG Donnell 65/65 tail w/ 100# B G Donnell. Circulated * BBLs good cement to the surface.
