13. Describe Proposed or Completed Operations (Clearly state all pertinent details, and give pertinent dates, including estimated date of starting any proposed work. Production on this well has dropped off significantly due to coal fines filling the well bore.

We plan on cleaning out the well bore with an air package to TD of 3769' KB. OH- 3369'KB thru 3769'KB. KB= 12'0". To clean out with air we will need to construct a water pit 30' X 50' X 10' deep and a blow pit 20' X 30' X 4'deep. The blow pit will drain into the lined (8 mil plastic) water pit. Pit will be fenced until pit is closed. After clean out is complete and all fluid removed, we will cover all coal fines within the plastic, folding the plastic over the top, and bury, reclaiming soil over pit and reseeding to BLM specs. All proposed work will be on existing disturbed well pad.

Proposed work is planned to begin in May of 1994, after approval of Sundry Notice.
