Workover was completed 6-21-95. Gas has increased substantially. Well was put back on production 6-24-95.

After cleaning out well bore, we ran a predrilled and plugged 17# 5 1/2" liner in 23# 7" casing. Liner hanger is set at 3285' KB and landed liner at 3760' KB. PBTD=3769' KB. Bottom of 7" casing is at 3350' KB. Tubing was landed at 3683' KB.
