Set 9 5/8" 36# K-55 BTC surface casing at 276'. Cemented with 195 sx class B STD w/20% CACL2. Circulated 4 BBLs to the surface. Pressure tested casing to 1000 psi. Drilled a 8 3/4" hole to a TD of 3315' on 12-6-90. Set 7" 23# K-55 LTC production casing at 3308'. Cemented with 560 sx class B 65/35 p22, tail with 100 sx cl B with 20% CACL2. Circulated \* BBLs good cement to the surface.

structions concerning the use of this form and the number of copies to be submitted, particularly with regard to local area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

## SPECIFIC INSTRUCTIONS
