Spud a 12 1/4" surface hole on 11-25-90 at 11:45 hrs. Drilled to 290'.
Set 9 5/8" 36" K-55 surface casing at 283'. Cemented with 16.5 lb/gal W/290 Cella. Circulated 9 BBLs to the surface.
Pressure tested casing to 1000 psi. Drilled a 8 1/2" hole to a TD of 3155' on 12-6-90. Set 7" 25" K-55 L-C production casing at 3148'. Cemented with 536 lb class B Western, tail with 100 lb class B Western. Circulated 100 BBLs good cement to the surface.
