GIH w/6-1/4" bit & tagged cement @ 3240'. Drilled out cement, then drilled new formation from 3319' - 3538' (TD). TD reached 0630 hrs 10/2/99. COOH. RIH w/underreamer & underreamed 6-1/4" hole to 9-1/2" hole from 3330' - 3538'. Circulated hole. COOH. Rotated and reciprocated hole w/air & mist, making sweeps for approx. 16 days, cleaning out to TD. GIH w/5-1/2" 15.5# J-55 casing (liner) and set @ 3537'. Top of liner set @ 3284'. Total of 253' of liner.

RU Blue Jet & perforated .75" holes @ 4 spf as follows:

3509'-3529'(20'); 3480'-3485'(5'); 3377'-3387'(10'); 3335'-3341'(6'); Total 41 feet = 164 holes

RD Blue Jet. RIH w/2-7/8" 6.5# J-55 tubing and set @ 3515' with "F" nipple set @ 3483'. ND BOPs & NU WH. PT-OK. Pumped off check. RD & released rig 10/19/99. Turned well over to production department.
