GIH w/6-1/4" bit & tagged cement @ 3500'. Drilled out cement, then drilled new formation from 3500' to 3761' (TD). TD reached 0815 hrs 10/3/99. COOH. Circulated hole. COOH. Rotated and reciprocated hole w/ air and mist, sweeping for approx. 15 days, cleaning out to TD. GIH w/5-1/2" 15.5# J-55 casing (liner) and set @ 3756'. Top of liner set @ 3503'. Total of 253' of liner.

RU Blue Jet & perforated .75" holes @ 4 spf as follows:

3716' - 3721' (5'); 3604' - 3620' (16'); 3583' - 3600' (17') Total 38 feet = 152 holes

RD Blue Jet. RIH w/2-7/8" 6.5# J-55 tubing and set @ 3753' with "SN" nipple set @ 3715'. ND BOPs & NU WH. PT to 3000 #for 30 minutes. OK. Pumped off check. RD & released rig 10/19/99. Turned well over to production department.
