The subject well's casing and cement was changed slightly. The availability of 8-5/8" BOP equipment for the surface casing made it feasible to change the surface casing from 7" (permitted) to 8-5/8" (actual). The size of the hole for the production casing was changed from the permitted 6-1/4" hole to 7-7/8" because of the difference in the strength bit. Using a larger stronger bit would save time as well as money, due to less drill time and less bit changeouts.

The following is planned:

Surface casing - 12-1/4" bit, 8-5/8" 24#, K-55 casing, 205 sx C1 H cement (247 c)  
Production casing - 7-7/8" bit, 2-7/8" 6.5# J-55 casing, Lead - 650 sx C1 H (1898 c)  
Tail - 220 sx C1 H (266 c)

Both surface and production casing cement is designed to be circulated to surface.
