Our APD extension expires 7/23/01 and we won't have our regular contracted drilling rig in the area to spud this well before then, so we are using MOTE to drill and set the surface casing on this well before the APD expires. To accommodate the rig, we wish to change the surface casing depth from 350' to 220'. This rig is only capable of drilling & setting casing up to 240'. The only other alternative was to reapply for the APD, but the location has already been built.
