Cmdt w/290 sx Class "B" neat cmt w/3% econolite, 0.25 pps flocele, 5 pps gilsonite (844 cu ft). Tail w/90 sx Class "B" 50/50 poz w/2% gel, 2% calcium chloride, 0.25% flocele, 5 pps gilsonite (127 cu ft). Circ 34 bbl cmt to surface. WOC. PT BOP & csg to 1500 psi, OK.
