

Cmdt w/344 sx Class "B" neat cmt w/3% econolite, 0.5 pps flocele, 10 pps gilsonite (1001 cu ft). Tail w/90 sx Class "B" 50/50 poz w/2% gel, 2% calcium chloride, 0.5 pps flocele, 10 pps gilsonite (127 cu ft). Circ 60 bbl cmt to surface. WOC.

1-14-00 PT csg & BOP to 1500 psi/30 min, OK. Drilling ahead.

1-15-00 Drill to TD @ 5742'. Circ hole clean. TOOH. Ran logs.
