Pumped 10 bbls mud clean, 10 bbls water spacer w/red dye then pumped Lead cement - 370 sx (879.3 cf - 156.6 bbl slurry) Type 3 35/65 POZ, 5#/sx Gilsonite, 1/4#/sx Cello-flake, 6% Gel, 10#/sx CSE, 3% KCl, 0.4% FL-25, 0.02#/sx Static free. Tail - Pumped 50 sx (70.2 cf - 12.5 bbls slurry) Type 3 cement w/1/4#/sx Cello-flake, 1% CaCl2. Dropped plug and displaced w/121 bbls FW. Plug down @ 0236 hrs w/1500#. Circ. 8 bbls cement to surface. WOC. ND BOP. Set slips and cut off 7" casing. NU WH & PT - OK. Test 7" casing, rams and manifold to 200# 3 minutes and 1800 # 10 minutes. Good test.
