

RIH w/6-1/4" bit & tagged cement @ 2978'. Drilled cement to 3034', then drilled ahead to TD @ 3320'. TD reached 11/27/00. Circ. hole. RIH w/9-1/2" under-reamer & under-reamed 6-1/4" hole to 9-1/2" hole from 3036' - 3320'. RIH & C/O to TD @ 3320'. R&R cleaning out hole w/air & mist assists. Surged well for approx. 7 days. R&R cleaning out to TD. RIH w/7" X 5-1/2' Baker Hyflow hanger and 5-1/2", 15.5# liner and set liner @ 3320' (315' of liner) and had top of hanger set @ 2999'. Had 32' of overlap. RIH and perforated liner @ 4 spf .75" holes as follows;

3087-3102'(15'); 3130-39'(9'); 3251'-56'(5'); 3261'-73'(12'); 3305'-18'(13'); Total 54' = 216 holes

RIH w/2-7/8", 6.5# J-55 tubing & set @ 3242' with "F" nipple set @ 3210'. ND BOP, NU WH. PT-OK. Pumped off expendable check. RD & released rig 12/12/00. Turned well over to production to first deliver.
