Drilled 12 1/4" hole and ran 9 5/8", 36#, J-55 New Casing and landed @ 244' KB. Cemented with 150 sacks of Class H Cement with 3% CACL2 and 1/4#/sack Celloflake (15.6#, Yield 1.18). Circulated 17 bbl's of cement to surface. WOC 12 Hours. Pressure Tested Casing to 1000#. Held OK.

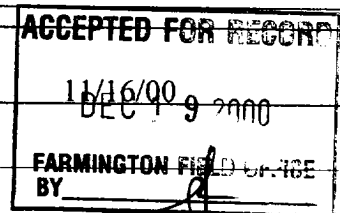
