RIH w/8-3/4" bit & tagged cement @ 290' Drilled cement from 290' - 341'. Drilled ahead to 3600'. Circ. hole. RIH w/7", 20#, J-55 casing and set @ 3596'. RU to cement. Pumped a preflush - 10 bbls water/red dye, then pumped 470 sx (1117 cf - 199 bbl slury) Type 3 cement 35/65 POZ L w/5#/sx LCM-1, 1/4#/sx Cello-flake, 6% gel, 10#/sx CSE, 3% KCl, 0.4% FL-25, 0.02#/sx Static free.

Pumped tail - 50 sx (69.6 cf - 12.4 bbl slurry) Type 3 w/1/4#/sx Cello-flake & 1% CaCl2. Dropped plug and displaced w/144 bbls FW. Bumped plug w/1500#. Circ. 2 bbls cement to surface. NU BOP, set slips and cut off casing. NU BOP, manifold and lines. PT casing, rams, lines and manifold to 200 # 3 minutes & 3000 psi - 10 minutes. Good test.

Note: Phillips has recently experienced problems loosing drilling fluid in the coal interval on wells drilled in the area. We discussed this problem with Jim Lovato (BLM) and decided to drill & set the intermediate casing above the Fruitland Coal to an effort to get good cement to the surface. Our production casing's cement will tie into the intermediate as planned.
