RIH w/6-1/4" bit & tagged cement @ 3390'. Drilled cement from 3390' to 3448'. Drilled ahead to 6684' TD. TD reached 5/4/01. Circ hole. RIH w/4-1/2" 11.6#, J-55 casing and set @ 6033'. Couldn't get any further. DV tool set @ 5224' and ported collar set @ 2608'. RU to cement. Pumped a preflush of 10 bbls FW, 10 bbls gel water, 10 bbls of FW/red dye. Lead - 80 sx (176.8 cf - 31.5 bbl slurry) Type 3, 35/65 POZ w/6% gel, 3% KCl, 0.4% FL-25, 5#/sx LCM-1, 1/4#/sx Cello-flake, 10#/sx CSE, 0.02#/sx Static Free. Tail- 25 sx (39.3 cf - 7 bbl slurry) Type 3, 35/65 POZ w/6% gel, 10#/sx CSE, 0.2#/sx Static Free, 0.75% FL-52, 0.2% CD-32 & 1/4#/sx Celloflake. Dropped plug & displaced w/93 bbls FW. WOC 2 hrs.

Pressure up & opened DV tool & pumped 2nd stage - Lead - 110 sx (356.5 cf - 63.5 bbl slurry) Type 3 cement 35/65 POZ w/5% gel, 3% KCl, 0.4% FL-25, 5#/sx LCM-1, 1/4#/sx Cello-flake, 10#/sx CSE & 0.02#/sx Static Free. Tail - 50 sx (70 cf - 12.48 bbl slurry) Type 3 w/1/4#/sx Cello-flake & 1% CaCl2. Dropped plug & displaced w/81 bbls FW. Plug down @ 0450 hrs 5/6/01 with 1990#. WOC. Kill well w/water. ND BOP, set slips and cut off casing. NU WH. RD & released rig. Will show PT casing and TOC results on next report. Plans are to run and cement a liner to TD.
