RIH w/2-1/16" tbg and set @ 6548' w/"F" nipple set @ 6541'. ND BOP. NU WH. Pumped off expendable check. RD & released rig 9/9/02.

Well turned over to production and put back on line as commingled on 9/11/02. Well will be DHC per Order 2915.
