Cleaned out to TD @ 3523'. Surged well with natural formation pressure for approx. 13 days. COOH. RIH w/5-1/2" 15.5# J-55 casing and set @ 3520' with Baker Hy-flow 3 hanger set @ 3249'. Top of hanger set @ 3249'. RU to perf liner @ 4 spf .75" holes as follows:

3340' - 3344' (4'); 3355' - 3375' (20'); 3473' - 3493' (20') Total 44 feet = 176 holes

RD Blue Jet. RIH w/2-7/8" 6.5# J-55 tubing and set @ 3478' with "F" nipple set @ 3477'. ND BOP & NU WH. Pumped off expendable check. RD & released rig 10/26/00. Well won't produce without pumping unit. 11/29/00 Installed Pump and rods. PT - OK. RD & released. Turned over to production to first deliver.
