Pumped 435 sx (1035.30 cf - 184.38 bbl slurry) Type 3 35/65 POZ w/5#/sx LCM-1, 1/4#/sx Celo-flake, 6% gel, 10#/sx CSE, 3% KCl, 0.4% FL-25 and 0.02#/sx Static Free.

Tail - 50 sx (70 cf - 12.46 bbl slurry) Type 3 w/1/4#/sx Celloflake & 1% CaCl2. Displaced with 136 bbls water. Circ. 15 bbls cement to surface. Plug down @ 1630 hrs 6/4/01. ND BOP, set slips and cut off casing. Installed & PT tubing head to 3000 psi. OK. PT rams, lines, manifold and casing to 200 psi 3 minutes and 2000 psi for 10 minutes. Good test.
