Pumped Tail - pumped 50 sx (70 cf - 12.46 bbl slurry) Type 3, 1% CaCl₂, 0.25#/sx Cello-flake. Displaced w/132 bbls water. Plug down @ 1055 hrs 5/30/02. Circ. 25 bbls cement to surface. ND BOP, set slips and cut off casing. RD & released rig 5/31/02.
