Pumped a preflush of 10 bbls mud clean, 10 bbls dye water. Then pumped 150 sx (211 cf - 37.57 bbl slurry) Type 3, 2% CaCl<sub>2</sub>, 0.25#/sx Cello-flake. Displaced w/15.75 bbls water, Plug down @ 0720 hrs 5/28/02. Circ. 15 bbls cement to surface. WOC. NE WH & NU BOP. PT-OK. PT casing to 200 psi low and 1500 psi high. Good test.
