Started R&R C/O to TD w/air assists. Surged well w/air assists, mist and foamer for approx. 14 days, C/O to TD. COOH. RIH w/5-1/2" 15.5# J-55 csing for liner. Set liner @ 3453' with top of hanger @ 3272' (30' overlap into 7" casing). RU Blue Jet & perforated liner @ 4 spf .75" holes - 3312'-19'; 3336'-42'; 3348'-51'; 3378'-89'; 3405'-09'; Total 31 feet = 124 holes. RD Blue Jet. RIH w/1 jt of 2-7/8" tubing set @ 3449', a crossover set @ 3411' and 2-3/8", 4.7# tubing to surface. ND BOP, NU WH. PU rods & pump. Space out rods and seat pump. PT-OK. RD & released rig 8/18/02. Turned well over to production to first deliver.
