Pumped a preflush of 10 bbls water, 10 bbls mud clean and 10 bbls dye water ahead of Lead- 430 sx (1023 cf - 182.19 bbl slurry) Premium Lite High Strength FM, 3#/sx CSE, 5#/sx Gilsonite, 0.25#/sx Cello-flake, 3% Potassium Chloride, 0.4% FL-25.

Tail - 50 sx (70 cf - 12.46 bbl slurry) Type 3, 1% CaCl₂, 0.25#/sx Cello-flake. Displaced w/132 bbls water. Plug down @ 0904 hrs 4/26/02. Had full returns, dye water to surface, but no cement. ND BOP, set slips and cut off casing. WOC 8 hrs. Ran Temp survey - TOC @ 300'. RD & released rig 0600 hrs 4/27/02. 4/29/02 Called BLM & OCD and received approval to proceeds without remediating cement.
